

RULES OF "#MyNCU" COMPETITION

1. ORGANIZER AND DURATION

1.1. The competition's organizer is Nicolaus Copernicus University in Toruń, located at 11 Gagarina Street in Toruń.

1.2. The competition shall take place between 1st March and 15th June 2016.

1.3. The date of announcing the competition's results is defined by section 5 of the Rules.

2. TERMS OF PARTICIPATION

2.1. The Competition's participant may be any natural person, with full legal capacity and in possession of an Instagram account, of nationality other than Polish and studying at Nicolaus Copernicus University in Toruń, or a student of Polish nationality studying at Nicoalus Copernicus University as a foreign participant of Erasmus+ programme (hereinafter referred to as 'Entrant).

2.2. The condition for participation in the Competition is following the Instagram profile of Nicolaus Copernicus University (<u>https://www.instagram.com/umktorun/</u>).

2.3. The condition for participation in the Competition is publishing the competing Picture on the Entrant's private Instagram profile.

2.4. Entrants are obliged to make themselves acquainted with the Competition's Rules. Meeting the Competition's terms of participation from paragraph 2.3. means accepting all the sections of Competition's Rules.

2.5. The organizer is not responsible for applications which have not reached them due to reasons beyond their control, such as Internet connection failure, improper tagging of pictures, or Instagram breakdown.

2.6. The organizer is not responsible for Entrants providing inaccurate personal details, or giving personal details of a third party. Providing inaccurate personal details results in forfeiting the right to receive a prize.

2.7. The pictures eligible to enter the Competition have to be taken by the Entrants themselves.



2.8. Participation in the Competition is free.

3. COMPETITION RULES

3.1. The Competition shall be conducted in the three following monthly parts during the following time periods: 1st part- 1 -31 March 2016; 2nd part- 1-30 April 2016; 3rd part- 1-31 May 2016. Each part shall be assigned a theme. The theme of Competition's part 1 is 'First Impressions', with its assigned hashtag being #NCUFirstImpressions. The themes of the next parts shall be provided to Entrants via the website <u>www.umk.pl/en</u> 2 days before the start of each Competition part.

3.2. The Entrants' task will be taking a photograph relating to the theme of each part, putting it their private Instagram account, and tagging it with #myNCU #TorunMoves #NCUsummer2016 as well as the theme's hashtag, which the equivalent of entering the Competition. Each Entrant may submit an unlimited number of pictures, properly labelled with the Competition's hashtags. An Entrant may take part in the Competition's selected part, or in all three of them.

3.3. Entrants are forbidden to publish content which is a violation of the Polish law, or is vulgar, offensive, propagating, supporting or promoting intolerance, violence, hatred or any form of discrimination.

3.4. The Competition is moderated by the Organizer. Moderating the Competition involves the Organizer's right to exclude any work which violates the Competition Rules, without the obligation to inform the Entrant.

4. COMPETITION RESULTS AND PRIZES

4.1. Verification of entries shall be conducted by persons nominated by the Organizer.

4.2. During each part, four winners shall be selected, one of each of the following categories:

- The most active Entrant (The Entrant who submitted the largest number of pictures during its single part);
- The author of the most popular picture (the picture which received the largest number of likes on Instagram);
- The author of the best picture (the picture considered the best by the Commission nominated by the Organizer)
- The author of the best picture of Toruń (the special prize founded by Toruń Municipal Council).



4.3. The prizes to be won are founded by Nicolaus Copernicus University and Toruń Municipal Council).

4.4. The Organizer reserves the right to award additional prizes. Information about them shall be provided, at the latest, on the date of announcing the results of each part.

5. ANNOUNCING RESULTS AND AWARDING PRIZES

5.1. Announcing the results of each part of the Competition shall take place within 2 workdays of its ending. The results shall be published on the website <u>http://www.umk.pl/en</u> within 7 days of the date of each part's resolution.

5.2. Regardless of the abovementioned terms, the winner of each part of the Competition shall be notified within 48 hours of the decision about the prize awarded.

5.3. The way of collecting the prize shall be decided upon individually with the Competition's Winner by the prize Founder, after the confirmation mentioned in paragraph 5.2.

5.4. Should there be no possibility to contact the Winner, or should the prize be waived by the Winner, the prize shall be awarded to the runner-up in a given category. Should it not be possible for the Organizer to decide the Winner, the prize is forfeited.

5.5. The laureates are not entitled to a financial equivalent of a Prize.

5.6. Submitting untrue or incomplete personal details shall be a reason for denying an Entrant a prize in case of winning.

5.7. The organizer shall not be responsible for the impossibility of or difficulty with using the prize due to reasons attributable to the Competition's Winner.

5.8. By submitting works for the Competition, the Entrants agree to the competition being conducted in accordance with the Rules. The Entrants also agree to their name and surname being published, as well as the information about receiving the prize, on the Organizer's websites and in publications, as well as other mass-media, for the purpose of announcing the Competition results.

5.9. By submitting works for the Competition, the Entrants agree to their personal data being processed for the purpose of Competition and for justified purposes of data administrator, while having the right to access and correct them. The personal data shall be protected according to Personal Data Protection Act (Dz. U. No 133/97, item 883).



6. THE PROCEDURE OF FILING AND DEALING WITH COMPLAINTS

6.1. In case of the Entrants' complaints concerning the Competition's course compliance with the Rules, the Entrants have the right to file a written complaint within 7 days of publishing the Competition results. The complaint must be sent by registered letter to the Organizer's address provided in paragraph 1.1. above, with the postscript "MyNCU – Reklamacja". After this deadline, complaints shall not be accepted.

6.2. Properly filed complaints shall be dealt with by the Organizer within 14 days of the date of filing. The Organizer shall deal with the complaints filed and inform the claimant of the decision.

7. FINAL PROVISIONS

7.1. The Rules are available for inspection at the Organizer's office, which is Centrum Promocji i Informacji UMK (The NCU's Centre of Promotion and Information) and Biuro Programów Międzynarodowych UMK (NCU's International Programmes Centre), in Toruń 11 Gagarina Street.

7.2. The Competition Rules may be amended: each Entrant shall be informed about the amendments via a news on the Organizer's website <u>http://www.umk.pl/en</u>, containing the collection of changes in the Rules, with the news being present on the website for at least 14 consecutive days.

7.4. Violation of the Competition's rules by an Entrant shall mean disqualification from the Competition.

7.5. In all matters not settled herein, relevant provisions of the Civil Code shall apply.
