

# SPEAKERS

## SESSION #1



### **Moderator: Dorothy Kelly, ARQUS**

Dorothy Kelly is a professor at the University of Granada (Spain), where she was Vice Rector 2008-2023. She was Chair of the Coimbra Group 2010- 2017 and a member of Spain's Bologna Experts Team 2010-2013. She has participated intensely in Spanish, European and international advisory boards and events in the field of higher education and its internationalization. She is founding coordinator of Arqus, Chair of the Spanish national network of universities participating in the EUI, and a member of the FOREU4ALL Board.



### **Ioana Dewandeler, European Commission**

A Policy Officer for Higher Education in the European Commission's Directorate General for Education, Youth, Sport and Culture where she is coordinating the policy dimension of the European Universities initiative. Ioana has over 17 years prior experience in various positions within the European Commission in the fields of higher education policy, strategy for the education, youth and sports programme Erasmus+, social sciences and humanities in research and innovation, and the socio-economic dimension of transport research policies. She studied economic and social public administration and EU law and litigation in Romania and France.



### **Beatrix Busse, EUinWell/FOREU4ALL**

Beatrix Busse is vice-rector for teaching and studies and professor of diachronic English linguistics at the University of Cologne, as well as the chief development officer of the European University for Well-Being. She is the inaugural board chair of FOREU4ALL, and serves as vice-chair of the executive board of the Coimbra Group. Her scholarly interests include corpus- and transfer linguistics, stylistics, and language (discursive place-making) in urban spaces.



### **Teofil Jesionowski, EUNICE**

Rector of Poznan University of Technology (PUT), honorary president of the Conference of Rectors of Polish Universities of Technology and a member of key academic boards. He initiated the European University EUNICE, led by PUT, believing internationalization and broad cooperation are essential to academic excellence.



### **Maria Kelo, European University Association (EUA)**

Maria Kelo is Director of Institutional Development at European University Association (EUA). The unit's work focuses on recognition, quality assurance, rankings, and learning and teaching, including the European Degree. She is a member of the Swiss Accreditation Council, vice-president of the European Quality Assurance Register, and co-represents EUA in the Bologna Process.

Before joining EUA in 2022, Maria was the Director of the European Association for Quality Assurance in Higher Education, and previously worked in different European organisations in higher education.

## **SESSION #2**



### **Moderator: Dorota Piotrowska, ECIU**

Dorota Piotrowska is a professor and Director of the Centre for International Cooperation at Lodz University of Technology. She coordinates Erasmus+, ECIU, and international projects on double degrees, partnerships, mobility, and rankings. She has introduced innovative teaching and quality assurance methods. Her research covers strategic and change management in higher education. She advises the Ministry of Education and acts as an expert for Polish National Agency for Academic Exchange (NAWA) and Conference of Rectors of Academic Schools in Poland (CRASP).



### **Vanessa Debiais-Sainton, European Commission**

Vanessa Debiais-Sainton is a Member of Cabinet for European Commission Executive Vice-President Roxana Mînzatu. She is responsible for the Union of Skills, education and training. She previously served as Head of Unit for European higher education policies and programme at the Directorate-General for Education, Youth, Sport and Culture, leading the development of key flagships such as European Universities alliances, a blueprint for a European degree, and the European Strategy for Universities.



### **Timothée Tourny, EU+**

Timothée Tourny is Secretary General and founding architect of the European University of Technology Alliance. An Associate Professor at Université de technologie de Troyes (FR), he is a graduate of ENS Paris and Paris-Saclay. He has authored over 45 peer-reviewed publications, patents, and book chapters, and has led six European research and innovation projects. He serves on the board of the French quality assurance agency CTI and acts as an expert advisor to international bodies on university governance and pedagogical reform.



### **Tayyeb Shah, European Association for International Education (EAIE)**

Tayyeb Shah is the Vice President of the European Association for International Education (EAIE) and Managing Director of HSC Education. He is a past Deputy Vice Chancellor of The University of Western Australia and served as Deputy Vice President at King's College London before that. Educated at the Universities of Oxford and Cambridge, SOAS, and Imperial College London, Tayyeb is also a Fellow of the Royal Society of Arts.



### **Anna Jurkowska-Zeidler, SEA-EU**

Lawyer, Professor at the University of Gdańsk, Vice-Rector for Cooperation and International Relations at the University of Gdańsk and Vice-Rector of the European University of the Seas (SEA-EU). She is the Chairwoman of the University Internationalisation Committee of the Conference of Rectors of Polish Universities. She is also working in the National Task Force for the Strategy for Internationalisation of Polish Higher Education.

## **SESSION #3**



### **Moderator: Patrycja Matusz, Polish Presidency**

Professor Patrycja Matusz is Vice-Rector for Internationalization at the University of Wrocław, where she oversees global engagement strategies. She is also Proxy for the Excellence Initiative – Research University Project and a member of the Executive Council of the ArQus European University Alliance. A Professor of Political Science, her research focuses on migration, integration, public policy, and higher education management. She has advised institutions such as the German Federal Ministry of Education, the Polish and French Ministries of Higher Education, and the Council of Europe. Currently, she serves as Plenipotentiary of the Minister of Science for European Affairs and Poland's Presidency in the EU Council.



### **Laurence Farreng, European Parliament**

Laurence Farreng (MoDem) has been a Member of the European Parliament since 2019. She is a member and coordinator of the Committee on Culture and Education. She is as well as a substitute member of the Committee on Legal Affairs and the Committee on Employment and Social Affairs. She has been in charge of the Erasmus + programme negotiations and implementation for her political group (Renew Europe) since the beginning of her first mandate, and is currently rapporteur for the report on the future of the European Universities Alliances. She works on various topics, such as audio-visual policies, regulation of AI, post-Brexit relations with the UK, and recognition degrees across the EU.



### **Janina Fengel, EUt+**

Janina Fengel is Deputy Secretary General of the European University of Technology (EUt+) and based in Darmstadt, Germany. Before, she was managing director of the Graduate School at Hochschule Darmstadt University of Applied Sciences, and in the management team of the university's Center for Research and Development after having previously worked for several years in managerial positions in industry and obtaining a PhD.



### **Sophia Karner, Una Europa**

Sophia Karner is Senior Policy Officer at Una Europa vzw, the alliance's central office in Brussels. In her role, Sophia advises on the setting of strategic policy priorities of the alliance, provides external policy expertise to Una Europa senior management, and drives forward collaboration with key stakeholders in Brussels and beyond. Sophia is also co-leading WP3 on Policy Dialogue in the FOREU4ALL project. Sophia has been working in Brussels in various policy-related roles for the past ten years. positions in industry and obtaining a PhD.



### **Krzysztof Wasilewski, EU4Dual**

Associate professor of media studies and political science at the Koszalin University of Technology, Poland; vice-rector for education, head of EU4Dual local office, leader of the Lighthouse Research Initiative - Interdisciplinarity in Social Sciences; head of the Regional and European Studies Department at the Faculty of Humanities and the Digital Humanities and New Media Lab; his academic interests include: new media, intercultural communication, and digital humanities; he has received stipends and scholarship from Freie Universität Berlin, Cambridge University, University of Michigan - Ann Arbor and the Polish National Science Center.

### **Moderator: Laura Howard, SEA-EU**

Laura Howard has held various management positions at the University of Cadiz (Spain) and was President (2014-2016) of the European Association for International Education (EAIE). Laura is co-author of the report “Internationalisation of Higher Education” prepared for the European Parliament in 2015. Between 2019 and 2024, she was Director for Internationalisation of Education and then General Director of the coordination team of the European University of the Seas (SEA-EU).



### **Veronika Kupriyanova, Academic Cooperation Association**

Veronika Kupriyanova re-joined ACA in 2020 and became Deputy Director in 2023. She leads policy, advocacy, and member engagement, and co-chairs ACA’s European policies peer group. With 15+ years in EU higher education, she focuses on internationalisation, mobility, talent attraction, and staff development.

She’s a published author and evaluator of international programmes. Previously, she worked at EUA, Vrije Universiteit Brussel, Humboldt-Universität zu Berlin, and in consultancy advising on international strategies.



### **Manja Klemencic, University of Ljubljana**

Senior Researcher at Faculty of Education, University of Ljubljana and Associate of the Department of Sociology, Faculty of Arts and Sciences, Harvard University where she was teaching for the past ten years. Her current research is on student agency and impact of European Universities alliances on students, and on the mechanisms and impact of alliances’ partnerships with and for external stakeholders. She serves as Joint Editor-in-Chief of European Journal of Higher Education, Co-editor of Understanding Student Experiences in Higher Education and Co-Editor of Higher Education Dynamics. She is a member of the HEInnovate expert group.

**Małgorzata Myśliwiec, Transform4Europe**

Polish political scientist. Her research expertise are political systems (with special focus on Spain) and public administration. The Institutional Coordinator of the Transform4Europe European University since 2020. The Dean of the Faculty of Social Sciences at the University of Silesia in Katowice (Poland) since 2024.

**Max Dropiński, SEMI conductors expert**

Max, an engineer and MBA graduate, advocates for creating a silicon and digital valley in Central Europe and supports key projects strengthening Europe's semiconductor industry. As an engineering and transformation manager, he leads international teams across engineering and sales. ## PARRALEL SESSIONS #5

**Moderator: Katarzyna Aleksy, National Agency for the Erasmus+ and ESC Programmes**

Director of Higher Education Programs at the Foundation for the Development of the Education System, she leads relations with the European Commission and National Agencies. Since 2007, she has managed Erasmus and scholarship programs, including those under Norwegian, EEA, and Swiss-Polish grants. From 2017 to 2024, she worked at NAWA, overseeing program launches and EU-funded projects, and served as ACA Treasurer. In 2020, she received the IRO's Forum award for advancing internationalisation in Polish higher education. She is a speaker at major international conferences and a member of the Ministry's Advisory Board for the EUI.



**Stephan Geifes, DAAD – National Agency for Erasmus+, Germany**

Stephan Geifes has been Director of Erasmus+ Higher Education at DAAD since 2020 and Vice-President of ACA since 2025. He has worked at DAAD since 1999, previously leading Transnational Education and Cooperation Programmes, directing the DAAD Paris Office, and serving as Secretary General of the Franco-German University. He studied History, Sociology, and Romance Languages in Bielefeld and Paris, earned a master's degree, continued at ENA, and completed a PhD in History in 2012. Stephan has published on European and international higher education exchange.



**Vidar Pedersen, Erasmus+ National Agency, Norway**

Vidar Pedersen is Director of the Erasmus+ National Agency in Norway, hosted in the Norwegian Directorate for Higher Education and Skills. He has worked in international education for the past 24 years and held various management positions in the directorate. He is an active participant in European networks and is currently a member of the Administrative Council of the Academic Cooperation Association (ACA).



**Pastora Martínez Samper, UEUE, Spain**

Pastora Martínez Samper is Commissioner for International Action at the Universitat Oberta de Catalunya (UOC) since 2023 and previously served as Vice-Rector for Globalization and Cooperation. She coordinates the OpenEU European University Alliance and is Vice President of the Spanish Network of European University Alliances.

She chairs the EUA Expert Group on Open Science and the CoARA group on academic career assessment. With over 20 years of experience in science management, she has held leadership roles at IDIBAPS, CIBERDEM, and IBEC. She holds a PhD in Physics, and master's degrees in science management and business administration.



**Carle Bonafous-Murat, France Universités in Brussels**

Carle Bonafous-Murat leads the Brussels liaison office of the French Conference of Rectors, where he represents French universities at European level and fosters cooperation with European institutions. Since 2019, he has managed the office located in the Maison Irène et Frédéric Joliot-Curie, where the conference shares premises with France's main higher education and research-performing organisations.



**Anna Kowalczyk, Erasmus Students' Network, Poland**

A graduate in philological studies from Adam Mickiewicz University in Poznań. A four-time Erasmus+ scholarship holder. She completed an internship at the International Office of Johannes Gutenberg University in Mainz (Germany). **Moderator: Fernando Galán, ARQUS**

Fernando Galán is Secretary General of the Arqus European University Alliance with over 10 years of experience in European higher education policy. He has held leadership roles at Crue Universidades Españolas, EURASHE and the European Students' Union, and has contributed to key initiatives with the EU, Council of Europe, UNESCO, OECD and quality assurance agencies.



**Iris Kimizoglu, European Students' Union, Slovenia**

Iris is the President of the European Students' Union (ESU) for the 2024/25 term. She previously served on the ESU Executive Committee and Presidency team, and has held student representative roles at all levels in Germany. Her work focuses on public responsibility, academic freedom, higher education governance and financing, and student social policy. She advocates for inclusive education and student rights. Iris is pursuing an M.A. in Political Management, Public Policy, and Public Administration at the University of Duisburg-Essen.



**Rita Dias, Erasmus Students' Network, Portugal**

Rita is 28 years old and hails from the coast of Portugal. She holds a Bachelor's in Political Science and International Relations and a Master's in Public Policy. A linguist by training, she earned her PhD from Ludwig Maximilian University of Munich and Jagiellonian University in Kraków. Since 2016, she has worked at the National Science Centre (NCN) as a Scientific Coordinator in Humanities and Social Sciences. She currently leads two major international programmes:

CHANSE, a Horizon 2020-funded consortium of 27 research agencies, and DIOSCURI, developed in cooperation with the Max Planck Society. She is also actively engaged in promoting the internationalisation of Polish science and serves on the Advisory Panel for the National Internationalisation Strategy.



**Barbara Curyło, FORTHEM**

University of Opole; Ph.D. in Political Science granted by University of Warsaw; one of founders of EUI FORTHEM Alliance and Director of FORTHEM Centre at UO; coordinator of FORTHEM Experiencing Europe Lab; member of 4EU4All Governance and Legal Framework Group. Her research interests focus on Europeanisation and her recent co-edited volume with Alex Frame The

European Universities Initiative and the 'Euro-internationalisation' of European Higher Education is the first collective contribution to studies on EUI in terms of Europeanisation and internationalisation.

**Moderator: Emily Helmeid, EUGLOH/FOREU4ALL**

Emily Helmeid is Secretary-General of the European University Alliance for Global Health (EUGLOH) and 2025 Vice-Chair of FOREU4ALL community of practice. Previously, she led international research and education initiatives at Sciences Po Paris, the French National Council for Evaluation of the School System, OECD and UNESCO. She is a two-time Fulbright grantee and holds a

master's in Applied Economics from the Paris School of Economics.



### **Anaïs Goulko, Campus France**

Anaïs Goulko is working as a project manager at the unit for European projects at Campus France, the French National Agency for the promotion of higher education, international student services, and international mobility, since 2023. She has worked for six years in the French diplomatic services abroad, and several years at international offices of French higher education institutions. She has 10 years of experience in organising and coordinating international higher education events or projects. She has studied social sciences in France and in Germany.



### **Agnieszka Chłoń-Domińczak, CIVICA**

Professor Agnieszka Chłoń-Domińczak is Vice Rector for Research and Director of the Institute of Statistics and Demography at SGH Warsaw School of Economics. She is also Deputy Managing Director at SHARE-ERIC and leads the SHARE project in Poland. ### **Mattia Bellotti, EUTOPIA**

Dr. Mattia Bellotti is the Secretary-General of EUTOPIA, an alliance of ten European universities and six global partners. With a diverse background in Higher Education, Research, Engineering, and European Affairs, he has contributed to shaping long-term, cross-border partnerships between higher education institutions. From pan-European education programmes at EIT Digital to EUTOPIA, Mattia has driven the development of programmes and projects connecting academia, industry, and policy.



**Piotr Kępski, Polish National Agency for Academic Exchange (NAWA)**

Piotr is Director of the Department of Programmes for Institutions at NAWA. He holds a PhD in Sociology and studied at the University of Warsaw, Trier University, and the National School of Public Administration. A former Robert Bosch Fellow, he has extensive experience in public administration. From 2004 to 2018, he worked at the Ministry of Science and Higher Education, focusing on EU cooperation and digital projects, and was a delegate to the Horizon 2020 FET committee. Since 2018, he has coordinated several NAWA programmes and now leads efforts supporting institutional internationalisation, including the 2024 European Universities programme.

## WROCLAW UNIVERSITY LIBRARY

There are more than 4.200.000 volumes together in Wrocław University Library and its departmental libraries.

- Books: more than 1 453 457 volumes.
- Journals: more than 429 212 volumes/units.
- Special collections: more than 500.000 volumes/units including: 407 304 units, 44 712 microfilms, 60 277 units of restricted collections (uncataloged).
- Restricted collections: more than 169 000 (uncataloged) volumes.
- Departmental libraries collections: more than 1.700.000 volumes including over: 13.000 units of uncataloged collections.

The library consists of:

- collections of the pre-war City Library and University Library - as parts of it burned down, in accordance with the war reparation agreement about 211.917 books were brought back,
- minor, incomplete collections including Piast Library from Brzeg, Prince Jerzy Rudolf library from Legnica, Jesuit college library from Kłodzko, parts of the Milich library from Zgorzelec, St. Peter and St. Paul's Church library from Legnica, a Cistercian library from Trzebnica, and also some well-protected parts of many other Lower Silesian libraries,
- very old collection known as "Bibliotheca Vetus", and a collection of gifts acquired on the basis of the bishop Carl Francis Neander testament,
- the Wrocław patrician Thomas Rediger Collection - Thomas Rediger donated his books to the city in his last will,
- St Mary Magdalene church library, based mostly on Jan Hess' (died in 1547) legacy,
- St Bernard church library whose beginnings are counted from 1502.



# ABOUT THE CITY



Wrocław is the economic, cultural and intellectual capital of Lower Silesia and the 4th largest city in Poland. It boasts fascinating architecture and a lively metropolitan cultural scene. Wrocław is situated to the north of the Sudety Mountains. It is close to both Germany and the Czech Republic. Odra river and its many tributaries and canals cut right through it creating 12 islands and 111 bridges.


