NICOLAUS COPERNICUS UNIVERSITY IN TORUŃ

Year 2021; Item 267

ORDER No. 161

of the Rector of the Nicolaus Copernicus University in Toruń

of 30 June, 2021

on the prevention of the spread of the SARS-CoV-2 virus among members of the community of the Nicolaus Copernicus University in Toruń in the period from July 1 to September 30, 2021.

Pursuant to § 52 sec. 3 of Order No. 37 of the NCU Senate of April 16, 2019 the Statute of the Nicolaus Copernicus University in Toruń (NCU Legal Bulletin of 2019, item 120, as amended) in connection with the Regulation of the Council of Ministers of May 6, 2021. on the establishment of certain restrictions, orders and bans in connection with the epidemic (Journal of Laws of 2021, item 861, as amended)

it is ordered as follows:

§ 1

The following rules are introduced to prevent the spread of the SARS-CoV-2 virus among members of the community of Nicolaus Copernicus University in Toruń, hereinafter referred to as 'the University'.

§ 2

1. University buildings are open to employees, doctoral students, students and participants of other forms of education, as well as tenants of premises located in these buildings and other persons staying in them with the consent of the competent University bodies.
2. Detailed rules for the use of the University buildings and their preparation for users are set out in Annex 1.

§ 3

1. Domestic and foreign business trips of academic teachers, doctoral students and students of the University as well as visits of domestic and foreign guests of the University take place with the consent of the Dean, director of a doctoral school or head of an organizational unit, respectively, and in compliance with the sanitary requirements.
2. Domestic and foreign business trips of employees who are not academic teachers take place with the consent of the chancellor or the deputy chancellor for Collegium Medicum - in the case of administration and service employees, or the head of the organizational unit - in the case of engineering and technical employees and librarians, in which the employee is employed and in compliance with sanitary requirements.

§ 4

1. Conferences, concerts, exhibitions, sports competitions and other events organized by the University are held in accordance with the requirements of separate regulations.
2. The rules and scope of activities of the University Sports Centre, apart from classes, approved by the appropriate vice-rector, are set out in Annex 2 to the order.
3. The principles and scope of activity of the College of Physical Education and Sport at Collegium Medicum, apart from classes, approved by the appropriate vice-rector, are set out in Annex 3 to the order.
4. The principles and scope of activity of the Academic Centre of Culture and Art 'Od Nowa', approved by the appropriate vice-rector, are specified in Annex 4 to the order.

§ 5

1. The University Library functions in accordance with the requirements resulting from separate regulations.
2. The rules and scope of activities of the University Library, approved by the appropriate vice-rector, are set out in Annex 5 to the ordinance.

§ 6

1. The Archives of the Nicolaus Copernicus University in Toruń functions in accordance with the requirements resulting from separate regulations.
2. The principles and scope of activity of the Archives of the Nicolaus Copernicus University in Toruń, approved by the appropriate vice-rector, are specified in Annex 6 to the order.

§ 7

1. No more than two persons may be accommodated in a room in a student dormitory, unless they run a shared household.
2. Accommodation in student dormitories is provided only by prior arrangement with the student residence administration.
3. Visitors are limited to one person per resident, with no possibility of overnight stays in the resident's room.
4. Detailed rules governing the use of student dormitories shall be laid down in Annex No. 7 to the Regulation, as agreed with the student self-government and the doctoral student self-government and approved by the respective Vice Rector.

§ 8

1. Resignation from residence in the student dormitory shall take effect on the date on which the application is submitted in writing.
2. In the event of leaving the student dormitory, the accommodation rate shall be reduced in proportion to the period of residence in the student dormitory, so that:
 - 1) residents who have left the student dormitory by the 15th day of the month shall pay for their stay in that month at half the monthly rate;
 - 2) residents who have left the student residence after the 15th of the month shall pay the full amount.

§ 9

1. Employees, doctoral students and students may submit to koronawirus@umk.pl any information and questions concerning the functioning of the University in an epidemiological emergency.

2. Any information to external entities on the functioning of the University within the scope of this Regulation shall be provided exclusively by the University Press Team.

§ 10

The organisation of education at the University is regulated by a separate order of the Rector.

§ 11

The Chancellor shall, by order, lay down detailed rules for the operation of the University's administration and the manner in which engineering, technical, service and library staff shall perform their duties during the period of restriction of the University's operation in connection with the prevention, counteraction and eradication of COVID-19.

§ 12

In all matters not regulated by the Order, decisions concerning the functioning of the University are made by the Rector.

§ 13

Order No. 137 of the Rector of the University of Nicolaus Copernicus in Toruń of 8 June 2021 on preventing the spread of the SARS-CoV-2 virus among members of the community of the University of Nicolaus Copernicus in Toruń during the period from 7 to 30 June 2021 is repealed. (NCU Legal Bulletin of 2021, item 219).

§ 14

The Order shall enter into force on 1 July 2021.
